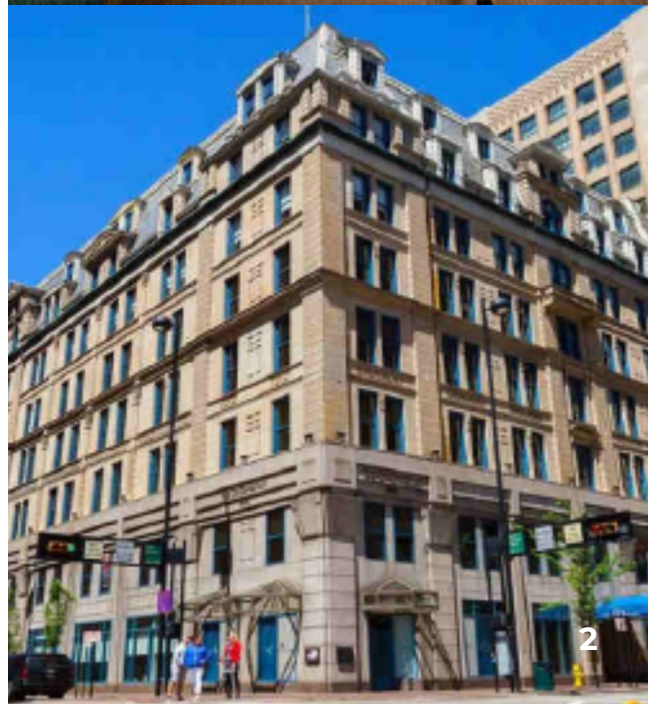
DAY 2 | ARK ENCOUNTER

PROGRAM INCLUDES

FULL TOUR PROGRAM: Round trip economy airfare; transfers with group to/from airport; hotel accommodation based on double occupancy; two meals daily; Transportation throughout by private motor coach. Entrance fees for sites to be visited per itinerary.

NOT INCLUDED IN PRICE: Items of a personal nature such as laundry; drinks, excess baggage any increase in taxes and fees that may occur between registration and issuing of airline tickets.

PAYMENT SCHEDULE: Deposit of \$750 due with registration of which \$500 per person is non-refundable. Final payment date is no later than January 31st, 2024.

TOUR DOCUMENTS: The name on your airline ticket must exactly match your name as it appears on your passport which must be uploaded before we can purchase your airline ticket. If applying for a new or renewed passport, upload a copy as soon as you receive your new passport.

ROOMMATES: If you purchase double occupancy and are unable to find a roommate, or your roommate cancels, you will be charged the single room occupancy rate.

LUGGAGE: Limit of one suitcase and one carry-on per person, not to exceed 50 pounds or 62 linear inches total.

TRANSFERS: Group transport between airport, hotel and piers is included in the standard program. However, those who request changes from the standard program are responsible for their own transfers. Transfer costs may vary by trip brochure.

CHANGES FROM STANDARD FULL TOUR

PROGRAM: Changes must be requested and approved in writing by GOMEGA Travel and Tours. A minimum of \$150 will be charged and individual transfers to/ from the airport are not included.

AIRLINE TICKETS: Tickets are nonrefundable; any changes are subject to the specific airline's policies.

FLIGHT TIMES: Subject to change by airlines without advance notice. GOMEGA Travel and Tours is not responsible for such changes or delays and does not reimburse expenses resulting from such delays.

ITINERARY LENGTH: Because airlines often change the flight schedules, GOMEGA Travel and Tours reserves the right to shorten or lengthen the itinerary accordingly and you will be notified in writing. If changes necessitate extra overnights, customers will be responsible for additional charges.

CANCELLATION FEES: From the day of registration to 120 days prior to departure the \$500 non-refundable registration fee will be charged. Thereafter, the following charges apply: 119-90 days \$750; 89-60 days 50% of total cost; 59-45 days 75% of total cost; 44 days to departure day 100% of total cost. All cancellation and refund claims must be made in writing.

REFUND REQUESTS: Allow up to 30 days for the process of any cancellation requests.

PROCESSING FEES: Any fees incurred during payment processing such as credit card fees, bank fees, GOMEGA Travel and Tours processing fees, etc. are non-refundable.
